### **Engro Fertilizer Limited (EFERT)**

**Earnings:** Engro Fertilizer Limited (EFERT) announced it 3QCY23 result. For the period, the Company reported consolidated earnings of PKR 9.6bn (PKR 7.17), up by +2.3xy/y, compared to profit of PKR 4.2bn (EPS PKR 3.13) in the same period last year. This brings total earnings for 9MCY23 to PKR 15.0bn (PKR 11.27), up by +57%y/y.

**Dividend/Payout:** The Company announced cash dividend of PKR 6.0/share along with the result bringing to total cash payout for 9MCY23 to PKR 12.5/share.

**Operating Performance:** During 3QCY23, Company's net sales improved by +85%y/y likely owing to higher offtake and fertilizer prices. Gross margins clocked in at 32% during the quarter compared to 27% in the same period last year, amid higher prices. Company's administrative cost increased by +38%y/y and Selling & Distribution costs increased by +56%y/y. Company's finance cost dropped by 14%y/y, owing to lower borrowings. Tax charge clocked in at PKR 6.2bn or 39% effectively higher when compared to 3QCY22 charge of 33%.
