### **Maple Leaf Cement Factory Limited (MLCF)**

**Earnings:** Maple Leaf Cement Factory Limited (MLCF) announced it 3Q'23 result. For the period, the Company reported consolidated earnings of PKR 1.9bn (EPS PKR 1.75), up by +20%y/y. this brings (mFY23 total earnings to PKR 6.2bn (PKR 5.76/share), up +43%y/y.

**Dividend/Payout:** The Company did not announced any cash dividend.

**Operating Performance:** During 3Q'23, company's net sales increased by 42%y/y. Moreover, gross profit margin remained flat to 27% compared last year same period. Administrative, selling and distribution cost jumped by 2x y/y. Finance cost dropped by 20%y/y. Tax charge clocked in at PKR 0.8bn or +30% effectively higher when compared to 3Q'22 charge of +24%.
