



INDEPENDENT AUDITOR'S REPORT TO THE CHIEF EXECUTIVE OFFICER OF IGI FINEX SECURITIES LIMITED ON STATEMENT OF LIQUID CAPITAL AS AT JUNE 30, 2020

Opinion

We have audited the Statement of Liquid Capital of IGI Finex Securities Limited (the Securities Broker) and notes to the Statement of Liquid Capital as at June 30, 2020 (together 'the Statement').

In our opinion, the financial information in the Statement of the Securities Broker as at June 30, 2020 is prepared, in all material respects, in accordance with the requirements of the Third Schedule of the Securities Brokers (Licensing and Operations) Regulations, 2016 (the Regulations) issued by the Securities and Exchange Commission of Pakistan (SECP).

Basis of Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs), as applicable in Pakistan. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Statement section of our report. We are independent of the Securities Broker in accordance with the ethical requirements that are relevant to our audit of the Statement in Pakistan, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Basis of Accounting and Restriction on Distribution

We draw attention to note 1 to the Statement, which describes the basis of accounting. The Statement is prepared to assist IGI Finex Securities Limited to meet the requirements of SECP, Pakistan Stock Exchange (PSX) and National Clearing Company of Pakistan Limited (NCCPL). As a result, the Statement may not be suitable for another purpose. Our report is intended solely for IGI Finex Securities Limited, SECP, PSX and NCCPL and should not be distributed to parties other than the Securities Broker, SECP, PSX or NCCPL. Our opinion is not modified in respect of this matter.

We draw attention to note 2 to the Statement, which highlights the fact that the short term liabilities of the Securities Broker exceeded 5 times of its Liquid Capital, which is in contravention of the ratio prescribed by SECP through its circular dated April 27, 2017 No. SMD/SE/2(20(2016)). Our opinion is not modified in respect of this matter.

Responsibilities of Management and Those Charged with Governance for the Statement

Management is responsible for the preparation of the Statement in accordance with the Regulations, and for such internal control as management determines is necessary to enable the preparation of the Statement that is free from material misstatement, whether due to fraud or error.

Those charged with governance are responsible for overseeing the Securities Broker's financial reporting process.

Auditor's Responsibilities for the Audit of the Statement

Our objectives are to obtain reasonable assurance about whether the Statement is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs as applicable in Pakistan will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this Statement.

1 Basis of Preparation

This statement is prepared in accordance with the requirement of the Third Schedule of the Securities Broker (Licensing and Operations) Regulations, 2016 and guidelines / clarifications issued by the Securities and Exchange Commission of Pakistan. The Accounting policies adapted in the preparation of this statement are consistent with basis used in annual audited financial statements of the Company

2 Minimum Amount of Liquid Capital

As per SECP circular No. SMD/SE/2(20(2016)) dated April 27, 2017, the short term liabilities of the Company shall not increase 5 times of Liquid Capital. As at June 30, 2020, the short term liabilities of the Company exceed the required limit by Rs 262.841 million, in contravention of the ratio prescribed by the SECP.
