



## **Review Report on Statement of Liquid Capital Balance**

**To the Chief Executive Officer of IGI Finex Securities Limited (the Securities Broker)**

### **Introduction**

We have reviewed the accompanying Statement of Liquid Capital Balance of IGI Finex Securities Limited (the Securities Broker) as at June 30, 2021 and notes to the Statement of Liquid Capital Balance (here-in-after referred to as the 'the Statement'). Management is responsible for the preparation of the Statement in accordance with the requirements of the Third Schedule of Securities Brokers (Licensing and Operations) Regulations, 2016, issued by the Securities and Exchange Commission of Pakistan. Our responsibility is to express a conclusion on the Statement based on our review.

### **Scope of Review**

We conducted our review in accordance with International Standard on Review Engagements 2410, 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity' which applies to review of historical financial information performed by the independent auditor of the Securities Broker. A review of historical financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with the International Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

### **Conclusion**

Based on our review, nothing has come to our attention that causes us to believe that the accompanying Statement is not prepared, in all material respects, in accordance with the requirements of the Third Schedule of Securities Brokers (Licensing And Operations) Regulations, 2016, and guidelines / clarifications issued by the Securities and Exchange Commission of Pakistan.

### **Emphasis of Matter – Basis of Accounting**

We draw attention to note 2 to the Statement, which highlights the fact that the short-term liabilities of the Securities Broker exceeded 5 times of its Liquid Capital, which is in contravention of the ratio prescribed by SECP through its circular dated April 27, 2017 No. SMD/SE/2(20(2016)). Our conclusion is not modified in respect of this matter.

### **Other Matter - Restriction on Distribution and Use**

Our report is intended solely for IGI Finex Securities Limited (the Securities Broker), SECP, Pakistan Stock Exchange and National Clearing Company of Pakistan Limited and should not be distributed to any other parties. Our conclusion is not modified in respect of this matter.

**1 Basis of Preparation**

This statement is prepared in accordance with the requirement of the Third Schedule of the Securities Broker (Licensing and Operations) Regulations, 2016 and guidelines / clarifications issued by the Securities and Exchange Commission of Pakistan. The Accounting policies adapted in the preparation of this statement are consistent with basis used in annual financial statements of the Company

**2 Minimum Amount of Liquid Capital**

As per SECP circular No. SMD/SE/2(20(2016)) dated April 27, 2017, the short term liabilities of the Company shall not increase 5 times of Liquid Capital. As at June 30, 2021, the short term liabilities of the Company exceed the required limit by Rs 301.2 million, in contravention of the ratio prescribed by the SECP.
