Fertilizer

Engro Fertilizer Limited (EFERT)

Earnings: Engro Fertilizer Limited (EFERT) announced it 1Q'23 result. For the period, the Company reported consolidated earnings of PKR 4.4bn (EPS PKR 3.3), down by 20%y/y.

Dividend/Payout: The Company announced cash dividend of PKR 3.5/share along with the result compared to PKR 5.5/share last year same period.

Operating Performance: During 1Q'23, company's reported +19%y/y increase in net sales supported by higher fertilizer prices. However, gross margins declined to 24% during the quarter compared to 30% in the same period last year, amid higher gas prices. Company's administrative cost increased by +24%y/y and Selling & Distribution costs increased by +22%y/y. Company's finance cost declined by 8%y/y, owing to debt repayment. Tax charge clocked in at PKR 2.4bn or 35% effectively higher when compared to 1Q'22 charge of 28%.
