Engro Fertilizer Limited (EFERT)

Earnings: Engro Fertilizer Limited (EFERT) announced its 1QCY25 result. The Company reported consolidated earnings of PKR 2.9bn (PKR 2.17) during 1QCY24, down by -63%y/y, compared to profit of PKR 7.8bn (EPS PKR 5.81) in the same period last year.

Dividend/Payout: The Company announced cash dividend of PKR 2.25/share along with the result.

Operating Performance: During 1QCY25, Company's net sales declined by -59%y/y clocking in at PKR 30.3bn as compared to PKR 73.8bn in the same period of last year. Net sales are also down by -64%q/q on the back of lower Urea and DAP offtakes. Gross margins increased to 35% during the quarter compared to 23% in the same period last year likely due to higher Urea prices. Company's administrative expenses increased by 12%y/y while selling costs declined by -27%y/y. Other Income fell by -76%y/y to PKR 0.31bn. Company's finance cost inflated by +6.8xy/y to PKR 1.1bn during 1QCY25 likely due to higher borrowings. Tax charge clocked in at PKR 2.0bn as compared to PKR 4.3 billion charged in 1QCY24. Effective tax rate during 1QCY25 stood at 41% as compared to 36% in the same period last year.
